

CAIRNS HARDWARE ROOFING & TRUSSES MANUFACTURING PROMO - TERMS AND CONDITIONS

ENTRIES – TRADE AND CASH ACCOUNT CUSTOMERS

1. Employees of the Promoter (Cairns Hardware Company ABN# 87 009 881 341) and related entities of the Promoter are ineligible for entries.
2. The promotion period commences on 1 April 2018 at 6.00am AEST and closes on 30 June 2018 at 5.30pm AEST.
3. Entries will be restricted to Trade Account and Cash Account holders of the Promoter.
4. An entry shall be received when roofing iron, gutter, flashing, insulation and accessories as well as timber trusses are purchased from Cairns Hardware for one (1) single residential dwelling (e.g. Lot 1850 Newry Trail, Smithfield Qld 4878).
5. The purchaser will receive one (1) entry for a truss confirmed sales order and one (1) entry for a roofing confirmed sales order for each single residential dwelling.
