INVITATION – TRADE AND CASH ACCOUNT CUSTOMERS

1. Employees of the Promoter (Cairns Hardware Company ABN# 30 005 032 333) and related entities of the Promoter are ineligible for invitation.
2. The invitation qualification period commences on 1 February 2026 at 6.00am AEST and closes on 31 May 2026 at 5.30pm AEST.
3. Invitations to the 2026 Trade Expo will be restricted to Trade Account and Cash Account holders of the Promoter.
4. An invitation shall be obtained for the first \$500 spent in one (1) single transaction at any of the promoter's stores, during the qualification period (1 February – 31 May), invoiced on the customers' account.
5. Subsequent \$500 spent in one (1) single transaction at any of the promoter's stores, during the qualification period, invoiced on the customers' account will not attract an additional invite.
6. The invite will be for one (1) account holder and one (1) guest. If the account is held in the name of a business, the invite will be issued in the name of the business. Representatives of the business attending are considered authorised to order on the business' behalf.
7. All transactions classified as cash sales or C.O.D. are excluded from eligibility.
8. The Promoter has the right to refuse entry.
9. It is the responsibility of the account holder to ensure all contact details are current and up to date with the Promoter. This includes postal address, phone number including mobile and email address.
10. Invitations will be emailed to qualified customers early June 2026. RSVP's must be received by 17 June 2026 to attend. Eventbrite ticket will be issued on RSVP. This must be brought to the event (digital or printed) for entry and to receive your lanyard.
11. No responsibility is accepted for late, lost or misdirected invitations or RSVP acceptances.
12. Additional invitations may be issued at the discretion of the Promoter.

MAJOR PRIZE DRAW

1. Information on prizes and how to enter form part of these Terms and Conditions. Entries not completed in accordance with these Terms and Conditions are ineligible. Participation in this competition constitutes acceptance of these Terms and Conditions.
2. Employees of the Promoter (Cairns Hardware Company ABN# 30 005 032 333) and related entities of the Promoter are ineligible to enter.
3. Suppliers and business affiliates of the Promoter (Cairns Hardware Company ABN# 30 005 032 333) are ineligible to enter.
4. To be eligible for the prize, the winning ticket holder must be in attendance at the time of the draw. If the winning ticket is in the name of a business, an authorised nominated representative must be present to collect the prize on behalf of the business.
5. The major prize draw is expected to start at approximately 9.00pm Thursday 18 June 2026. The draw will continue until all prizes are claimed.
6. If a winning entry is drawn and the account holder or an authorised nominated representative fails to present themselves within one (1) minute to receive the prize, there will be a redraw. This process will continue until a winner is determined.
7. There will be several major prizes drawn, in order of value, highest to lowest, chosen at random from all eligible entries received. Any account holder who has already won a prize will be ineligible to win a second major prize. The Promoter's decision is final and no correspondence will be entered into.
8. To be eligible to win any of the major prizes the customer must hold a current, and not in arrears, Trade Account or Cash Account with the promoter and have an official 2026 Trade Expo invitation issued by the promoter.
9. All major prizes remain the property of the promoter until all necessary paperwork and transfer documents have been completed and finalised.
10. All major prize winners will make themselves available for promotional photos with the promoter and all major business partners of the promoter on the completion of the Trade Expo. Major prize winners must authorise the use of the photographs for publication in promotional material.
11. Customers satisfying the invitation criteria, as per Invitation Terms and Conditions (above), can receive entries into the major prize draw the following two ways:

1. Before 2026 Trade Expo: Trade Account and Cash Account holders, will receive one (1) entry ticket for the major prize draw for every \$500 spent in a single transaction, invoiced on their account at any of the promoter's stores or manufacturing divisions. Double tickets will be issued for invoiced transactions at Cairns Truss & Frame Centre and Supatruss Townsville.
2. At 2026 Trade Expo (Thursday 18 June, 6pm – 8:30pm): Trade Account and Cash Account holders will receive one (1) entry ticket for the major prize draw for every \$100 spent on Trade Expo Promotional Products on the night.
e.g. \$100 = 1 ticket, \$198 = 1 ticket, \$210 = 2 tickets etc. Purchases from different suppliers cannot be accumulated.
12. Entries on the event night will only apply to sales orders entered on a customer charge account. No option or facilities will be available for cash or card transactions at the Trade Expo event.
13. Quotations will not attract any entries into major prize draws. Pre-existing account customer quotes will not be accepted nor converted to a sales order that would be eligible for ticket entries.
14. Examples of ineligible entries include, but are not limited to:
 - a. Any pre-existing customer sales order or invoiced sale processed outside of the competition period.
 - b. Any order processed during the 2026 Trade Expo night for products not on promotion list.
